

## INTERNAL POOL REGULATIONS

### HOURS

During the summer period, access is allowed from 8 am to 8 pm. During the autumn period, access is allowed from 8 am to 6 pm.

### ACCESS

Access to the private pool complex by badge is strictly reserved for the personal use of the occupants of the buildings in the superstructure of the condominium "DALLE TERRE-PLEIN DE FONTVIEILLE," including guests of the Columbus Monte-Carlo hotel, and no guests will be admitted. It is strictly prohibited:

- for injured individuals showing signs of contagious diseases or skin diseases,
- for unaccompanied children under 8 years old,
- for individuals in a visibly unclean state, • for unauthorized visitors/accompanists.

Walking on the "beach" is only allowed barefoot or with beach shoes reserved for that purpose.

### USE - RESPONSIBILITY

An organization plan for surveillance and rescue has been established. It will be updated annually based on any changes that may occur.

### LOCKER ROOMS

Shoe lockers are available at the entrance of the complex. Users have access to a changing room (Ladies - Gentlemen) for dressing and undressing.

### HYGIENE MEASURES AND SANITARY RULES

The use of the footbath and showers before accessing the pool is mandatory.

### UPDATED - MARCH 2023

In addition to the means of rescue, this document specifies the access hours and the maximum number of people allowed. A turnstile counting system has been installed. Access to the pool will be prohibited once the tolerated number of people is reached. Outside of opening hours, the use of the private pool complex is strictly prohibited for anyone. Under no circumstances can the responsibility of the condominium, the property manager, or their employees be sought, as users act at their own risk. The same applies to personal belongings. During opening hours, a lifeguard service is provided. By decision of the general assembly on July 23, 2014, private swimming lessons can be given at the pool by lifeguards in the morning from 8 am to 10 am and in the late afternoon from 6 pm to 8 pm.

#### **SPECIAL RECOMMENDATIONS IT IS NOT ALLOWED TO:**

- cause damage to the building or various installations. Damages will be repaired at the expense of the relevant co-owner(s).
- access the pool and beach outside of the posted hours, • smoke, litter any kind of trash (papers, objects, cigarette butts, etc.), or spit on the ground,
- engage in violent games, pushing, or any behaviour that disrupts tranquillity and order,
- run on the beaches,
- play with balls, even foam ones, in or out of the water,
- use fins, diving suits, and masks; only swimming goggles are allowed,
- use bodyboards, boats, inflatable mattresses, or any large objects,
- stand on rocks and platforms or dive from those points,
- use lounge chairs without towels or monopolize them excessively,
- reserve equipment (chairs or mattresses),
- use small tables as footrests,
- use transistors,
- bring animals, glass containers, or alcoholic beverages,
- have picnics around the pool area,
- use soaps or similar products,
- contaminate the water in any way,
- and, in general, through their behaviour, disturb the tranquillity of other users and the proper functioning of the facilities.

#### **ATTIRE**

Decent swimwear is required. Even young children are not allowed to swim naked. Swimwear is prohibited in the hotel lobby.

#### **CLEANING AND CLOSURE**

To carry out specific cleaning and maintenance work, the premises will be closed for at least half a day per week, every **THURSDAY MORNING** until 12 pm.

#### **OBLIGATIONS**

All users, without exception, for the well-being of all, must comply with the rules set out in this regulation and those posted on-site. They will be required to obey the instructions of the security personnel and the person in charge of pool surveillance. In case of disobedience, they will be solely responsible. If necessary, the site managers may even close the pool complex, after informing the members of the syndicate council, if they deem it necessary.

#### **SECURITY**

The following rules are reminded:

- It is forbidden to leave young children unattended, even if equipped with a buoy, life jacket, armbands, etc.
- It is forbidden to enter technical rooms.
- It is forbidden to leave chemicals within reach of children.
